## Campus Closure Update

It is with incredibly heavy hearts that we inform you that The San Francisco School campus will remain closed through the end of the school year. We, the Executive Committee of the Board of Trustees, the Administration, and the SFS Emergency Preparedness Team, have determined that, at this time, the risks for reopening campus outweigh the potential benefits.

As we pondered creative scenarios for even a limited reopening, we identified ethical and logistical constraints that make it unfeasible. These include but are not limited to:

- Concern with issues of equity associated with a family or staff's ability to attend school
- Anxiety among many community members about returning to campus
- The need to develop extensive protocols/practices for all who enter campus
- The challenge of safe physical distancing and preventative measures for our students, especially with the PS/K and younger elementary grades
- Unsustainable strain on our staff to continue preparing distance learning while simultaneously pivoting to classroom learning
- Our commitment to doing our part for the greater good in fighting the pandemic by observing physical distancing

Regardless, The San Francisco School is in session until our final day of school on June 3. Our students will be learning and socializing to the greatest extent possible. Rather than preparing for a return to campus that is subject to cancelation from a COVID-19 setback, we will continue to deliver and enhance the best virtual program possible.

Over the course of the shelter-in-place directive, we hope that you have continued to value your family's place in our SFS community. While so many other schools have been slow to start online instruction, our quick conversion to the Distance Learning Plan in mid-March has allowed us to implement and refine an academically solid program with social-emotional support that will be sustainable for the remainder of the year.

As we move forward through this uncertainty, be assured that we will continue to do our absolute best to keep your children safe, intellectually engaged, and supported in a way that is true to our SFS tradition.

For many of us, the value of being part of The San Francisco School community as we shelter in place has been immeasurable.
